55. Introduce Ordinance: Read By Title Only, Waive Full Reading, and Hold Public Hearing for ORDINANCE NO. 1131, AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HOLLISTER AMENDING AND RESTATING CHAPTER 5.42 "MEDICAL MARIJUANA FACILITIES REGULATORY PERMIT" TO TITLE 5 "BUSINESS LICENSES AND REGULATIONS" OF THE HOLLISTER MUNICIPAL CODE

Description: This Medicinal Marijuana Administrative Ordinance will provide for cultivation, dispensing, manufacturing processes to be performed on, and other ancillary services provided to Medicinal Marijuana businesses. The ad hoc committee of Councilmembers Ray Friend and Karson Klauer has reviewed the new Medical Marijuana Regulation and Safety Act (MMRSA) that consists of three separate bills (AB 243, AB 266 & SB 643) which were enacted together on Sept 11, 2015. The bills create a comprehensive state licensing system for the commercial cultivation, manufacture, retail sale, transport, distribution, delivery, and testing of medical cannabis. All licenses must also be approved by local governments. The included ordinance initiates this process, and will be followed with regulations that can be adopted and updated to account for foreseeable changes at state and federal level relating to marijuana use and regulation.

Recommendation:

- 1.) Introduce Ordinance, read by title only, and hold Public Hearing.
- 2.) Discuss and provide input to staff on any further changes to ordinance – that provide a two-part regulatory process whereby a use permit can be conferred on real property with appropriate conditions to minimize, if not eliminate impacts on neighboring properties; and an operator's permit to qualified and screened individuals. Bring back Ordinance for second reading and adoption along with proposed regulations.
- 3.) Authorize the City Manager to seek an RFQ for entities to provide a study of costs and impacts on city services if adopted, and set the matter for second reading and FINAL ADOPTION on August 1, 2016.

Status: This item was pulled from the Consent Agenda by Councilmember Klauer on June 6, 2016, who questioned the thinking behind the proposed Resolution. He said four years of drought cannot be relieved by one year of water savings, and that he does not want to increase water usage at this time. Councilmember Friend said that the State Water Resources Control Board has declared the drought to be over, but he agreed with Councilmember Klauer that it is still necessary for the City to recharge its aquifers. The City Council voted unanimously to bring this item back for discussion and possible action on June 20, 2016.

Recommendation: That the City Council ADOPT Resolution 2016-81, revising the City's Water Shortage Emergency and Implementing the City's Water Shortage Contingency Plans.

I. NEW BUSINESS:

81. Designation of Voting Delegate and Alternate(s) for League of California Cities Annual Conference.

Description: The League of California Cities Annual Conference will be held in Long Beach, California from October 5 – October 7, 2016. The City Council should designate a Voting Delegate and up to two (2) Voting Alternates if anyone is planning on attending this year.
