- 14. **TITLE**: Resolution No. 2017-97, Approving A Reimbursement Agreement for the Allendale Project.

DESCRIPTION: Resolution No. 2017-97, a Resolution amending the General Plan of approximately 81.01 acres APN 053-370-038, 053-370-037, 019-130-027, and 019-130-026 from High Density Residential which requires 12 to 35 dwelling units per acre to Medium Density Residential which requires 8 to 12 dwelling units per acre and to expand the sphere of influence to encompass the entire site and another ordinance to pre-zone14.1. (APN 019-130-027 and 019-130-026) to Medium Density Residential Performance Overlay Zoning District and Re-zone (APN 053-370-038 and 053-370-037) to Medium Density Residential Performance Overlay Zoning District and a Resolution adopting an Environmental Impact Report and Mitigation Monitoring and Reporting Program was approved December 5, 2016.

SUMMARY: In order for the City to secure infrastructure construction for the project, and as conditioned, the property owner is requesting that the City form the City of Hollister Communities Facilities District Number 5 (Infrastructure Construction) (the "CFD") which will establish a special tax on the new homes and apartments within the development. This special tax will be levied and collected annually and used to design and construct improvements within the project. This process was discussed, negotiated and included in the Development Agreement between City and Developer wherein City covenanted to assist Developer in this process. (See Development Agreement page 13-14 and 16 attached.)

The Development Agreement provides in pertinent part:

"Developer may desire to initiate assessment or community facilities district proceedings to finance of all or portions of the design, acquisition and construction costs required to be paid for improvements to be designed and constructed pursuant to the Components. City shall diligently process such application . . . "(Section 3.2, Page 13) [Emphasis added.]
