Stage 1: Applicant and facility eligibility: *Application is evaluated for completeness, including any required agreements and documents.*

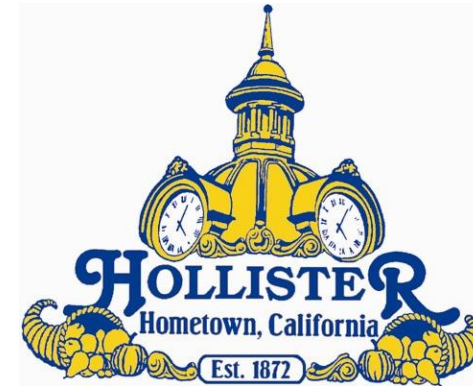


Stage 2: Applicant and facility Evaluation: *Considers various rules and regulations required under the City of Hollister Municipal Code.*



Stage 3: Applicant and Facility Selection: *Public Hearing- City Council determines whether to issue or deny the cannabis facility permit.*

About our Services

The office of Cannabis Affairs (OCA) is an extension of the Development Services Department that regulates the local cannabis industry in the City of Hollister. OCA's role is to coordinate the implementation of the City's cannabis laws and regulations.

SOME OF THE TYPES OF MATTERS HANDLED BY THE OFFICE:

- Regulate and implement best practices for adult-use and medicinal cannabis businesses;
- Work together and assist other city departments in the implementation of cannabis ordinances and regulations;
- Engage the cannabis industry and community to ensure all cannabis regulations are followed;
- Collaborate with the state to create uniform regulations.

Permitted Cannabis Facilities

- Cultivation
- Manufacturing
- Distribution
- Testing
- Dispensing/ Retail

Zoning Districts Where Cannabis Facilities are permitted:

- North Gateway (NG)
- West Gateway (WG) no dispensaries
- Airport (AS)
- Industrial Business Park (IBP)
- Light Industrial (M1)

Sensitive Use Buffer Requirement

- Private or Public School 600 Feet
- Conforming Religious Institutions 150 Feet
- Conforming Residential Use 150 Feet

- Licensed Rehabilitation Facilities 150 feet

Fees

- ✓ Application Fee for all license types: \$8,812.80
- ✓ Cultivation Fee: \$7 per square foot
- ✓ Manufacturing: 5% of gross sales
- ✓ Distribution: 5% of gross sales
- ✓ Dispensaries: 5% of gross sales
- ✓ Testing: 5% of gross sales

Things to know:

- Licenses are non-transferable.
- All Regulatory permits expire one year from its date of Issuance and must be renewed.
- Outdoor cultivation is prohibited.
